

Federal Crosscutters – Equivalency





- Assistance amount equal to the federal grant
- State may identify borrower, project, or group of projects to apply requirement
- Only those borrowers/projects will need to meet certain Federal requirements
- Project cannot be separated to avoid compliance



A/E aka QBS aka RFQ Procurement

Qualifications Based Selection...known by many names




- QBS....Request for Qualifications (RFQ)....and Architectural and Engineering (A/E) Procurement
- Usually, requirement is satisfied via certification form
- Sometimes requirement is met by long-standing state requirements (Oklahoma)
- Sometimes an applicant can pre-qualify engineering firms based on best fits for certain types of projects and the certification can cover multiple projects/years
 - Ex: One RFQ round can certify a firm for CSO, another for green stormwater, another for WWTF upgrade, etc.
 - This should be coordinated with state to be on safe side!!



Environmental Review-Procedure







Definition:

A class of actions as determined by the review agency that **do not** <u>individually or cumulatively</u> **have a significant effect on the human environment** and for which, therefore, neither an environmental assessment nor an environmental impact statement is normally required.

Use of Categorical Exclusions can save time and reduce paperwork



Cured-in-place lining of a sewer

Replacement of a sewer/water main within the same trench Replacement of treatment facility or pump station equipment with no increase in station capacity

Actions within the footprint or boundary of an existing facility



Fiscal Sustainability Plan (FSP)



Self-Certification	FSPs MUST Contain:
 States may allow recipients to self-certify or to complete an FSP CWSRF program is NOT required to collect or review the FSP If a community is self-certifying, this is due at loan closing For systems completing an FSP as part of the loan process, EPA strongly recommends that the CWSRF's require FSPs be completed before final disbursement 	 An inventory of critical assets An evaluation of the condition and performance of those assets A certification that the assistance recipient has been evaluated and will be implementing water and energy conservation methods as part of the plan A plan for maintaining, repairing, and replacing the treatment works and financing those activities "Asset management-light"




Only required for: Loan Recipients + Treatment Works Projects



Cost and Effectiveness




- Almost every state has a self-certification form

- Iowa SRF has a laundry list of resources for sustainability and energy/water conservation






CWSRF Green Project Reserve (GPR)




There is no requirement that GPR projects be subsidized





Davis Bacon



SRF Specific Requirements: Davis-Bacon





The Davis-Bacon Act of 1931 mandates that prevailing wages be paid by all contractors and sub-contractors on all federally funded and federally assisted public works projects in excess of \$2,000



The Davis-Bacon Employee Rights poster and a copy of the prevailing wage determination must be posted and protected from the weather at all job sites



Davis-Bacon records must be maintained for 3 years after the completion of the project







Collect weekly payroll compliance reports (aka certified payrolls) as completed and submitted by contractor and sub-contractors



Submit Davis-Bacon certification(s) to SRF agency



Spot check payroll compliance reports for each contractor and subcontractors at least twice during the life of the project



Conduct employee interviews on a self-determined risk-based schedule



Review apprentice/trainee registrations on a risk-based schedule

Davis-Bacon: Contractor Responsibility





Produce weekly payroll reports and collect weekly payroll reports from subcontractors. Submit all weekly reports to borrower



Maintain records of fringe benefit plans



Allow confidential access to employees for interviews






American Iron & Steel (AIS)

SRF Specific Requirements: American Iron & Steel



- Requires all DWSRF and CWSRF assistance recipients to use iron and steel products at are produced in the United States for the construction, alteration, maintenance, or repair of public water supply systems or treatment works.
- Applies to all products that:
 - Are made primarily of iron or steel
 - Listed in the Consolidated Appropriations Act of 2014 P.L. 113-76
 - Permanently incorporated into the project






What constitutes "primarily made of iron or steel"?	 A product that has more that 50% of its material cost made up of iron or steel. Manufacturers must certify as to whether their product meets American Iron & Steel (AIS) requirements.
What is a "listed" product?	 Lined or unlined pipes or fittings; manhole covers; municipal castings; hydrants; tanks; flanges; pipe clamps and restraints; valves; structural steel; reinforced precast concrete; and construction materials
What does "permanently incorporated into the project" include?	 Any iron or steel product buried or left in place (e.g., sheeting or trench box). Spare or backup parts

SRF Specific Requirements: American Iron & Steel







Complying with AIS – Certification Letter

Must come from manufacturer and not the product supplier

Must list the name and location of the project

Must describe the product being delivered to the project site

Must name where the product was manufactured

Must specifically reference the American Iron & Steel requirement

Must be signed by a company representative or printed on company letterhead



American Iron & Steel: Waivers!!



Remember: All waivers require coordination between borrower, SRF program & EPA

Cost Waiver:


Inclusion of iron and steel products produced in U.S. would increase the overall project cost by more than 25 percent; only one waiver approved so far.

Availability Waiver:

Most common form of waiver; the quantity of products is not available or will not be available in a reasonable time.

Public Interest Waiver: Applying AIS requirements would be inconsistent with the public interest; decision time longer that Availability Waiver due to complicated evaluation process.







Build America Buy America (BABA)



Included in the Infrastructure Investment and Jobs Act (IIJA)/Bipartisan Infrastructure Law (BIL)

Requires iron, steel, manufactured products, and construction materials used in the project are produced in the United States

Administered by the Made In America Office (MIAO) of the Office of Management and Budget (OMB), not the USEPA

Applies to all infrastructure projects that receive federal assistance not just CWSRF and DWSRF projects

BABA is an equivalency requirement. Applicable CWSRF and DWSRF projects must comply with <u>both</u> BABA and AIS



Applies to items consumed in, incorporated into or affixed to an infrastructure project.

BABA covered items should be classified as iron and steel, or manufactured products, or construction materials:

 Iron and Steel - Items that are predominantly iron or steel, unless another standard applies under law or regulation; all manufacturing processes, from the initial melting stage through the application of coatings, must occur in the U.S.



BABA waiver categories are like AIS

Unreasonable Cost Waiver:

Inclusion of iron, steel, manufactured products, or construction materials produced in the US will increase the cost of the overall project by more than 25 percent.

Nonavailability Waiver.

Types of iron, steel, manufactured products, or construction materials are not produced in the US in sufficient and reasonably available quantities or of a satisfactory quality.

Public Interest Waiver:

Applying the domestic content procurement preference would be inconsistent with the public interest.



National Waiver


Minor (Ferrous) Components Waiver: Allows the iron and steel product manufacturer to include non-domestic or unknown sourced, minor iron or steel components in BABA-compliant products up to 5% of material cost of the product.



Disadvantaged Business Enterprises Women-owned Business Enterprises Minority-owned Business Enterprises (DBE/WBE/MBE)



The EPA's Disadvantaged Business Enterprises authority ensures recipients of EPA financial assistance and their prime contractors, seek out, and wherever possible, utilize MBE, WBE, and other DBE firms when procuring services, equipment, supplies, and construction on EPA funded projects.

Signage



Capitalization grant award condition.

- Can be part of bid documents/construction contract or handled as separate documents.
- Can be the standard project sign at the worksite. Must include the EPA logo.
- Other acceptable signage options include poster or wall signage in a public building, insert in water or sewer bill, newspaper or periodical advertisement, online signage, and press release.





Telecom



Telecom Services and Equipment

- Cannot procure or obtain equipment, systems, or services that use "covered telecommunications equipment or services".
- Covered brands: Huawei, ZTE, Hylera, Dahua, others.
- Products and services include automatic meter reading technology, advanced metering infrastructure, instrumentation control systems, and security cameras.
- Applies to: DWSRF & CWSRF equivalency projects;
 CWSRF admin funds; all DWSRF set-asides.

Intended to provide assurances that a non-federal entity has adequate internal controls in place, and is in compliance with program requirements


